



## JerseyCAN Education Advocacy Fellowships

JerseyCAN's Education Advocacy Fellowships are paid opportunities for New Jersey teachers and parents (Fellows) to learn about and engage in education policy and advocacy work in New Jersey.

### The Program

JerseyCAN is building a vibrant advocacy community for NJ teachers and parents through its Education Advocacy Fellowships.

JerseyCAN's NJ Teacher Leader Policy Fellowship and Parent Champions for Strong Schools Fellowship provide NJ teacher and parent Fellows with opportunities to participate in year-long fellowships to study the NJ education policy landscape, hone their advocacy skills, and achieve collective and individual advocacy goals.

In addition to engaging in high-quality professional learning and networking opportunities, each **Fellow will receive a \$2,500 stipend** for their commitment to this work.

### What to Expect

Convenings take place throughout the year both virtually and in-person in Central NJ. Content is rich in current research, expert discussions, and exploratory activities designed to expand participants' knowledge and understanding of the current NJ education policy landscape. Fellows are also supported in taking action to advocate at the state or local level.

Throughout the course of these fellowships, participants will work with fellow teachers and parents, as well as across fellowships, as they:

- Conduct research within a current key priority area\* and identify a problem of practice to address within their selected area;
- Work with other parent and teacher fellows to learn the advocacy process and establish their own advocacy goals;
- Achieve a short-term advocacy milestone; and
- Increase their professional network and opportunities to advocate.

**Please note that attendance is an integral part of the fellowship, so only those candidates with full availability to attend all virtual meetings and in-person convenings should apply.**

- **Innovation:** Designing and expanding creative, research-informed approaches to teaching, learning, and school design that respond to the evolving needs of students, families, and communities.
- **Career Pathways:** Advancing opportunities that prepare students for postsecondary success in both college and careers, such as early earning of college credit while in high school, apprenticeships, and industry-aligned learning experiences.
- **Foundational ELA & Math:** Strengthening early and sustained instruction in math and literacy to ensure all students build the essential skills they need to thrive academically.

Teacher leadership also allows practicing teachers to meaningfully contribute to the development and implementation of education policy.
4. Robust parent advocacy, or families' efforts to promote healthy education policies and practices, benefit children throughout the state. Parents and families are the number one advocates for our young people; by giving them influence and input around educational decisions, educators and communities can join together in advocating for the best possible outcomes for our students.

## To Apply

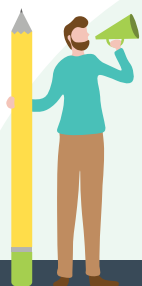
To apply for this Fellowship, participants must:

- Be open to **JerseyCAN's mission and vision**;
- Be passionate about leading state or local advocacy work in one or more of this year's key priority areas;
  - Innovation: Designing and expanding creative, research-informed approaches to teaching, learning, and school design that respond to the evolving needs of students, families, and communities.
  - Career Pathways: Advancing opportunities that prepare students for postsecondary success in both college and careers, such as early earning of college credit while in high school, apprenticeships, and industry-aligned learning experiences.
  - Foundational ELA & Math: Strengthening early and sustained instruction in math and literacy to ensure all students build the essential skills they need to thrive academically.
- Have a minimum of two years of experience teaching in New Jersey's schools AND/OR be a parent to a New Jersey student; and
- Commit to attending all meetings and convenings and completing any associated readings or activities for the convenings.
